Outagamie County: The Cities of Kaukauna and Seymour. The Villages of Bear Creek, Hortonville, Shiocton, Black Creek and Nichols. The portions of the Villages of Little Chute and Howard located in the County. The Towns of Black Creek, Center, Cicero, Ellington, Freedom, Kaukauna, Oneida, Osborn, Seymour, Vandebroek, Bovina, Deer Creek, Hortonia, Liberty, Maine, and Maple Creek.
